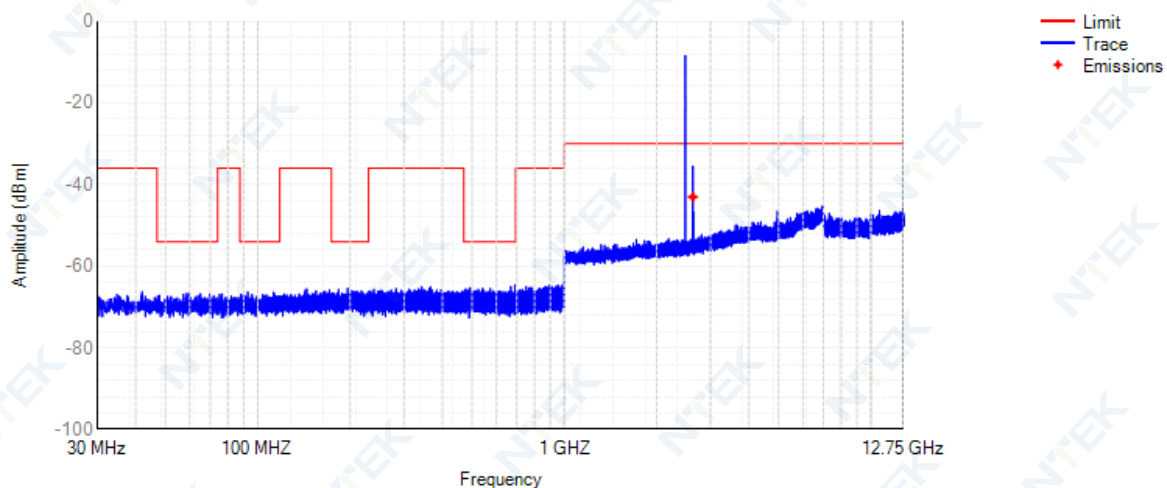
Transmitter unwanted emissions in the spurious domain

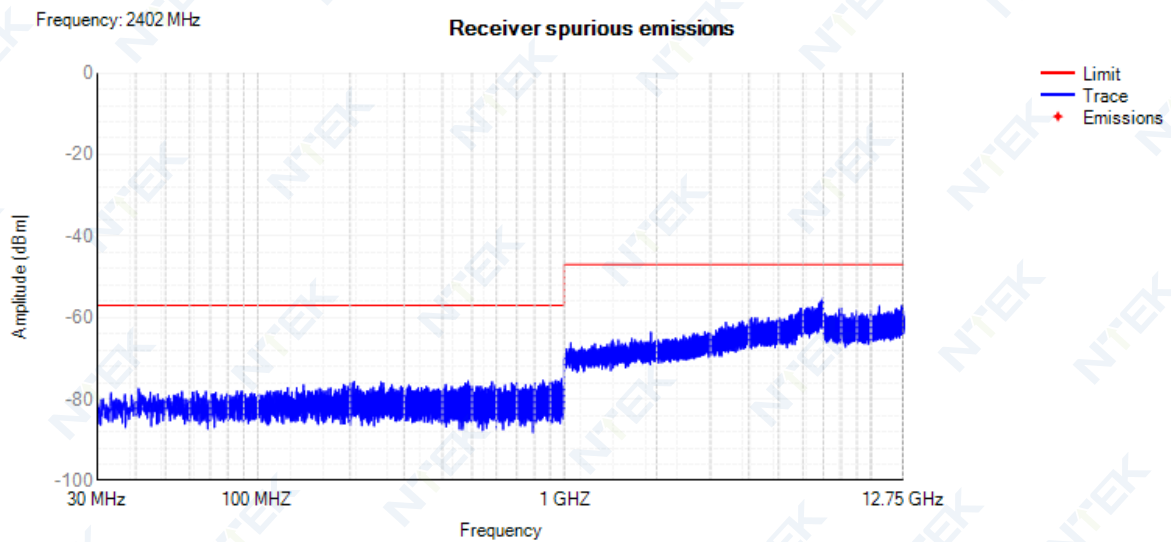

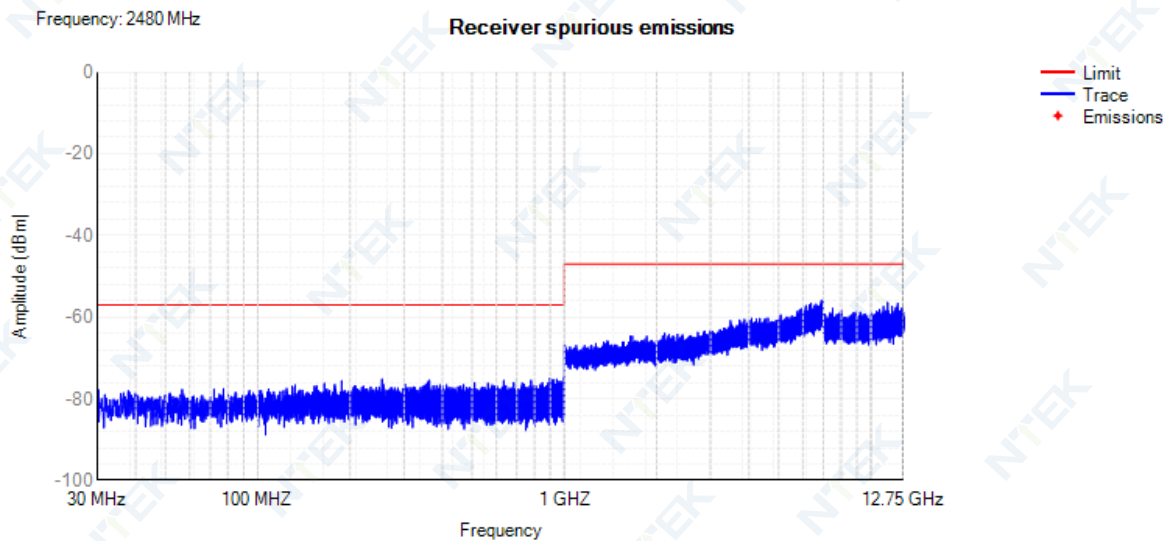

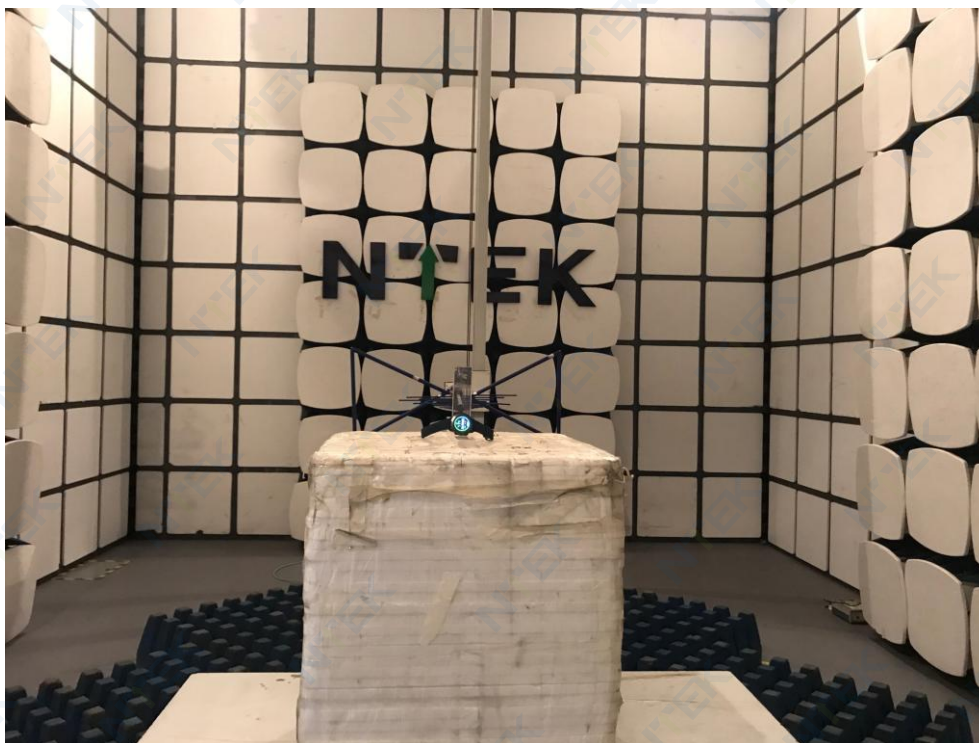
