### Limitations / Restrictions

- Body SAR was tested with a separation distance of 5 mm.
- Charging only with charger mentioned under Optional Components
- Only the frequency bands mentioned under Technical description in this Certificate have been declared as operable. This device also contains frequency bands that are not operational in EU member states, and are working only under control of a network. These bands have not been assessed.



### Notes
