Limitations / Restrictions

- Charging only with charger mentioned under Optional Components
- Body SAR was tested with a separation distance of 5 mm.
- Only the frequency bands mentioned under Technical description in this Certificate have been declared as operable. This device also contains frequency bands that are not operational in EC member states, and are working only under control of a network. These bands have not been assessed.
- 5GHz WiFi, has been presented as implemented by hardware but has been declared as blocked by the actual software version.



Notes

1. This certificate will not be valid if the manufacturer makes any changes or modifications to the approved equipment, which have not been notified to, and agreed with PHOENIX TESTLAB.
